# CONTINUOUS LEARNING PERIOD AND REQUIREMENTS



- Acquisition Workforce Professionals holding a FAC-C Pro, FAC-COR or FAC-P/PM certification are required to obtain the required continuous learning points (CLPs) within the two-year common continuous learning period.
- The current CLP period is May 1, 2024, through April 30, 2026.
  - Only training during this period can count towards CLP requirements
    - ✤ FAC-C Pro = 100 CLPs
    - ✤ FAC-COR Level I = 8 CLPs
    - ✤ FAC-COR Level II and III = 40 CLPs
    - ✤ FAC P/PM Level I, II and III = 80 CLPs
- CLPs earned above the requirement within any reporting period do not roll over to the subsequent period.
- In general, no single activity should be used to accumulate all CLPs required for certification maintenance.

### **CONTINUOUS LEARNING VALIDATION**

- SATERN is the agency's internal learning system that provides a wide variety of training to the NASA workforce.
- Although SATERN and FAI CSOD both serve as training resources for the agency, **only FAI CSOD** serves as the system of record for FAC-C maintenance.
- You can access a report in SATERN that summarizes the hours for learning activities earned in the system.
- It is recommended that you combine point request for consideration of training events that are earned in small increments.
- For training events that earn 8 CLPs or more, employees can submit a combined request as long as each event is accompanied by a completion certificate.
- Generic CL entries are NOT acceptable. CL point request submitted without detailed titles/topics will NOT be approved.
