### **New Project Information**

Following a thorough analysis of the [sand transport patterns](#) within the project vicinity, NASA has identified a new Preferred Alternative (Alternative 1) that would involve beach fill and seawall extension only. The Preferred Alternative would not include sand retention structures (i.e. breakwaters, groins).

After surveying commercial and recreational fisherman and analyzing the potential effects of dredging Blackfish Bank, NASA has removed the Blackfish Bank Shoal as a proposed source of sand for the SRIPP. A new unnamed shoal, approximately 1.5 nautical miles east of Blackfish Bank, will now be considered in addition to the original Unnamed Shoal as a potential [borrow site](#).
